Objective

Grady County School District is soliciting proposals in accordance with the terms and conditions of this Request for Proposal (RFP). This RFP provides services sought, requirements and evaluative criteria for an Internet Service Provider and requests a response from all prospective vendors, including pricing and service descriptions. The selected vendor must be registered with the SLC, have a current SPIN identification number and provide multiyear contracts.

Background Information

Grady County School District is a public K-12 school system located in South-west Georgia and currently serves approximately 4600 students. The system consists of 5 elementary schools, one middle and one high school.

Services Required

The school system is looking for a provider to supply high speed dedicated Ethernet Telecommunications Service (includes Internet Service) via fiber optic cable. This will consist of Internet/Data transport with the capacity of 100Mbps or greater. Connection must terminate in a 100Mb or greater Ethernet connection handoff.

The vendor must be able to guarantee network availability at least 99.8% of the time in a calendar month, and packet delivery of 99% or greater, except for outages caused by the customer's equipment, fiber cuts by third parties, acts of God or other Force Majeure events.

The vendor must provide a mechanism for trouble ticket reporting by the customer and offer a telephone response time of no greater than one (1) hour and, if necessary, initiate a physical response within four (4) hours.

Vendor should provide firewall and/or other necessary equipment to accommodate proposed bandwidth plus provide manual fail-over configuration to GaDOE provided Internet connection. Option for increased bandwidth at yearly renewals.

Right to Reject

The customer reserves the right to accept/reject/award proposals where such action is in the best interest of the Grady County School District. The customer reserves the right to award without further discussion. Therefore, responses should be submitted initially with the most favorable terms that the vendor could propose. The district reserves the right to reject the proposal of a vendor whom in the opinion of the Technology Services Department is not in a position to adequately perform the contract.

Bid Award

The winning vendor will be required to enter into an executor contract at the time of bid award. The contract will be in compliance with the guidelines of the Universal Service Program. The contract will provide for voluntary extensions of the contract expiration and service substitutions. Execution of the contract and inception of the project will be contingent on, a FUNDED Commitment Decision Letter from the Schools and Libraries Division for the associated Funding Request Number (FRN), and issuance of a Purchase Order from Grady County Schools referencing the contract number and FRN.
